The past fiscal year once again provided the Culture & Heritage committee of the St. Andrew's Society of Winnipeg (SASOW) the opportunity to support a limited number of successful initiatives and events designed to promote our Scottish heritage & culture and to improve the Society's financial stability.

Events that promoted our culture and heritage included a "Kilt Skate" and a "Whiskey Tasting Evening" and allowed the committee to prepare for one of our most successful public relations ventures to date, "The Pop-up-Piper" (more on this initiative in next year's report).

Unfortunately, due to the restrictions resulting from the COVID-19 pandemic, our annual "Ceilidh" had to be cancelled for 2020, along with several other events that would have been considered for SASOW grant support.

The committee also assisted in the purchase of merchandise such as SASOW Scotch Tasting Glasses and eyeglass cleaners.

The committee also began planning initiatives for the 150th anniversary of the SASOW, which will primarily occur in 2021-- if health and pandemic restrictions allow.

COVID-19 sidelined this committee as it did everything else and we can expect the epidemic to shape our lives for the foreseeable future. NO meetings held since last meeting due to the pandemic.

The co-chairs have met unofficially and discussed future direction of committee.

IRC had completed a process in March to re-evaluate it's role, shifting from a leadership role to a supportive one.

We culled the country's growing library of books on Indigenous themes and compiled a reading list, many by First Nation and Metis authors, to stimulate discussion around Truth and Reconciliation. The list was posted to the society's website. To further define the supportive focus, the co-chairs also put their efforts toward tailoring a land acknowledgement statement for the society.

The society currently uses a standard adopted from the federal government and while it serves the purpose, this kind of statement would serve a significant purpose: To frame the society's Indigenous relations and give us an opportunity to set out our long-term goals.

To that end, human rights agency, Amnesty International, posted a tool in 2017 to guide organizations through a question-and-answer process on land acknowledgements.

The co-chairs were working with two drafts at the time of this report.

The Finance Committee is a Standing Committee of the Board of Managers. The Society Governance By-law describes the functions of the Finance Committee:


"This Committee has responsibility for ensuring the development of the annual budget by the Executive Committee. The Finance Committee will review the quarterly financial statements, including performance relative to the budget. The Committee may make recommendations to the Executive Committee and the Board regarding fiscal matters and financial policies. The Committee shall perform other such duties as may be assigned by the Board".

During the 2019-2020 fiscal year the Finance Committee carried out the quarterly and annual reviews of the financial results of the Society and the Trust Fund, relative to the budget and to the previous year, and reported upon such to the Board. Due to the uncertainty created by the COVID-19 pandemic, the committee did not meet in May or June and postponed until a video conference meeting in September 2020 its review of the proposed budgets for the Society and the Trust Fund for the year ended June 30 2021.

In 2018 the Finance Committee proposed and led the development of a comprehensive Annual Report of the Society and the Trust Fund including the year's activities, history of the Society, listings of committees and members, as well as the annual financial statements.

St. Andrew's Society Treasurer's Report for 2019-2020 Fiscal Year

Attached are the 2019-2020 Financial Statements for the St Andrew's Society of Winnipeg and for the St Andrew's Trust. Below is a summary of the statements:

The St Andrews Society of Winnipeg

There were two events held in 2019-2020 meant for the promotion and enjoyment of Scottish culture and also to raise funds for our two organizations. The Whisky Tasting raised \$3,695, which is more than last year. Everyone I spoke to really enjoyed the variety of whiskeys from around the world. The St Andrew's Dinner had less attendees than last year but still raised \$6,550 for the Trust and was a spectacular evening! Unfortunately the planned 2019-2020 Ceilidh was cancelled due to Covid. We had budgeted a \$2,865 profit from the Ceilidh.

Overall the two events raised approximately \$7,000 for the Society and Trust.

Several promotional activities were initiated by the society to increase its visibility. These projects resulted in a net cost to the Society in 2019-20 of \$5,319. This promotion is an ongoing, multi-year process.

The net cost of \$5,319 included purchasing \$4,000 worth of Glencairn glasses with our logo, and \$2300 of eye glass cleaners with the St Andrews Society logo on them. We also supplied 10 dinner tickets to the Winnipeg Free Press as part of a long term advertising contract. We still have several boxes of the glasses and cleaners and other merchandise which may be sold or given out as promotional gifts. Sales of some of the glasses and other merchandise generated \$2,100 which was used to offset the above expenditures.

Finally, the membership service part of the society ended up \$2,361 in the hole. This is due to many factors but the loss more or less equals a drop in paid membership of nearly \$2,000 from last year.

At year end we are in an excellent financial position with \$38,911 in the bank net of funds committed to future activities.

The St. Andrew's Society of Winnipeg Trust Fund

As mentioned above, The Trust received \$6,550 from the St Andrew's dinner and it also received \$3,275 in other donations in 2019-20.

In addition The Trust received an annual allocation in the fiscal year from the Endowment Fund held by the Winnipeg Foundation in the amount of \$10,105. It also earned interest and members bonus in the amount of \$3,917 from the Steinbach
