Greetings from the President



Jae Eadie, President

I am finding it hard to believe that my term of office as the Society's 114th President is coming to its conclusion. This year has flown by quickly but it's been a busy and productive one for our Society.

My wife, Rhoda and I were pleased to host the traditional New Year's Day Levee at the Hotel Fort Garry where some 50

or so Society Members came to enjoy good fellowship, food and beverages to begin the year 2019. We were also honoured to have the Cameron's Commanding Officer, L/Col. Hugh Atwell and a number of his colleagues attend our Levee, as well as a piper and some of the Cameron Cadets. A slight hiccup occurred during our festivities when a large hotel water pipe burst on one of the upper floors of the hotel, which caused a considerable amount of water damage to the lower floors. Luckily for us, our meeting venue escaped any damage and as things eventually settled down we were able to continue to enjoy the Levee. It was a most unique way for our Society to inaugurate the New Year.

This year, our Society joined the Robert Burns Association of North America (RBANA) for one year as we believe being a member of RBANA will provide the Society with some great networking and promotional activities going forward.

The Society hosted another very successful year with their special events and fundraising. Of note are The Great Canadian Kilt Skate in early January, the first-ever family-friendly Ceilidh in April, the Whiskys of the World in September and the 148th Annual Dinner with Doug Speirs as a guest speaker in November. Many thanks to the chairs and members of these committees who are noted in this annual report.

Our Society continues to provide financial support through the Society Trust to a number of organizations in the promotion of Scottish culture and heritage in Winnipeg and Manitoba. Among others, this year we have provided grants to ScotDance Manitoba for their dance festival held in February. We have also provided support to the Winnipeg Police Pipe Band, the Winnipeg Scottish Festival, the Manitoba Highland Games, and our Cameron Cadets.

We continue to take advantage of modern technology for our record keeping and to make it easier for folks to take out memberships or to renew existing memberships on-line using Interac E-Transfer instead of writing cheques. The Board approved a recommendation from Peter Heavysege and the Membership Committee to streamline the membership application process by deleting the requirement for a nominator and seconder for new-member applications and we have deleted the former \$25.00 initiation fee as the costs of welcoming a new member to the Society are now quite minimal.

Along with some other members of the Society, I attended, as an observer, a Forum organized by Mayor Brian Bowman's Indigenous Advisory Circle to hear some panelists discuss reconciliation issues. Some weeks earlier, some inaccurate and somewhat disparaging comments were made by the Mayor and some of his staff about Donald A. Smith (Lord Strathcona, the Society's first President) and others of that era, and I wanted to have that record corrected. Unfortunately there was no opportunity provided for audience participation with the panelists. However, this is a matter that the Society will need to keep a watching brief on going forward.

As Society President, I am automatically a member of the Queen's Own Cameron Highlanders Advisory Board and in that role I've tried to attend as many of those board meetings as I possibly can to make certain our Society is represented. I was also pleased to be invited to attend the 106th Annual Ceremonial Review of the 407 Queen's Own Cameron Highlanders Cadets at Minto Armouries, and I was also pleased to attend the Queen's Own Cameron Highlanders of Canada Officers Mess Dinner at the Hotel Fort Garry.

In June, the Clan Sinclair Association (Canada) celebrated their 50th anniversary at a Gala Dinner in Winnipeg, which was superbly organized by our own Society Board member, Luke Settee. This was the first time this event was held in Winnipeg and it was a great event to be at. The Right Honourable Malcolm Sinclair, Earl of Caithness and Hereditary Chief of Clan Sinclair gave a very thoughtful speech and also participated in a most interesting rendition of the Address to the Haggis. Some enjoyable entertainment was provided by Indigenous Drum Dancers and by the Winnipeg Police Pipe Band.

This summer we were saddened to learn of the passing of the Society's Bard, Dr. Glen Lowther. He was a member of our Society for over 50 years and served as President from 1993 - 1994. Many of us will remember his Scottish wit and his Scottish brogue when he would bring greetings from our sister Societies around the world at our annual Gala Dinner. It was Dr. Lowther who, in 2014, initiated the by-law amendment that allowed for the admission of women as members in the St. Andrew's Society of Winnipeg. Dr. Lowther's foresight in this

regard has made our Society stronger and more relevant in these times and his legacy will be ever-lasting. To quote from Scripture: "Well done, good and faithful servant."

The St. Andrew's Society of Winnipeg was an active participant on the Peguis-Selkirk Bicentenary Committee which led, in 2017, to the very successful celebrations of that event. Since then members of that committee have been lobbying the provincial government to approve the erection of a monument on the grounds of the Manitoba Legislative Building to commemorate the signing of that historic treaty. The provincial government recently gave its approval to erect such a monument so now this committee, with continued support from our Society will be working to design an appropriate monument and conduct negotiations with the provincial government for an appropriate site on the grounds where the monument can be erected. This continues to be a work in progress.

Our next Society's annual Gala Dinner will take place on November 29 and while there will still be many of our traditional features, such as pipers, Haggis, and some fine malts, we'll have a bit of a different twist as far as entertainment goes. This year, being the 100th anniversary of the Winnipeg General Strike, we're very excited to have local composer/producer/writer Danny Schur and his team presenting some musical excerpts from his feature film musical Stand! which commemorates some of the happenings that took place in the general strike. This will be a gala dinner not to be missed!

The St. Andrew's Society of Winnipeg has been served by a very dedicated and hard-working team on its Board of Managers and, working together, the Board has led the way in making our Society grow stronger, both in membership and financially. During this past year as the Society's President, I have enjoyed working with each and every one of these dedicated folks. Our Society is in very good and capable hands with these good people at the helm.

And finally, I want to sincerely thank all members of the St. Andrew's Society of Winnipeg for allowing me the honour and privilege of serving as your 114th President during this past year.


Events and Fundraising Committee

This by-aw also created the position of Honorary Chief of the Society, which invokes ancient clan associations. Elder Jim Bear, Honourary Patron of the Society, honoured this custom by gifting eagle feathers from this land for the Honourary Chief's bonnet. The eagle feathers were presented by myself at a smudge ceremony at Upper Fort Garry Park with the board in attendance.

The newly formed Indigenous Committee is progressing with its plans for a speaker series, a possible Society bursary at the University of Manitoba, and a program of reconciliation with an existing organization.

Treasurer's Report Concerning the St Andrew's Society 2018-19 Fiscal Year

As the treasurer of the St. Andrew's Society of Winnipeg I have prepared and attached statements of Financial Position and statements of Operations for The St. Andrew's Society of Winnipeg (The SASOW) and The St Andrew's Society of Winnipeg Trust (The Trust). These Financial Reports were prepared from the bank records and supporting documents of both organizations plus the 2018 fiscal financial statements prepared by the prior treasurer.

The St Andrew's Society of Winnipeg

The SASOW's main functions are to provide services for its members and to preserve and promote the Scottish culture and heritage in Winnipeg and Manitoba.

The Financial Report shows revenues from membership fees and the costs of the services provided to the members. There is a small surplus for the year as we were not billed in 2018-2019 for rent at our prior storage facility. No amount has been expensed for this rent as it is unclear if a liability exists or will exist.

There are also other events and activities in which The SASOW is involved.

Events and activities:

In order to promote Scottish culture (as mentioned above) The SASOW presents certain public events and sells Scottish merchandise. Four major events were run by the SASOW in 2018-19 that were open to the public. Details of the results of these events and the financial results for each organization are included in the Financial Report but in summary the four events resulted in additional funds to The SASOW and The Trust of \$10,110 from several hundred ticket sales, raffles, sales of items and sponsorships. The St. Andrew's Society of Winnipeg is in an excellent financial position with \$45,787 in cash on hand after allowing for \$1,713 in accounts payable.

In 2019 The Trust received funds from bank interest, The annual St Andrew's Dinner, the St Andrew's Endowment fund, and donations to the Speakers Fund and to general revenues. The total of these receipts was \$27,633. The Trust made grants to a number of pipes bands and other Scottish organizations as well as to help fund a significant historical publication. The total of these grants was \$15,500. The recipients of these grants are listed in the financial report.

In addition, as is our usual practice, the cultural entertainment for The SASOW functions were paid for out of the Speakers fund from The Trust as part of its mandate. Amounts from the Speaker's fund paid for a piper/comedian who entertained the guests at the annual St Andrew's Dinner and also a Gaelic band that played at the inaugural Ceilidh as well as the Winnipeg Police Pipe Band who also entertained at the Ceilidh. Total outlays were \$6,708. A reconciliation of the Speaker's fund activity is also included in the Financial Report. The Trust currently has significant funds on hand, most of it allocated to anticipated major projects but also sufficient to make a large number of grants in the 2019-20 fiscal year.
