At its inception, the Society had two objectives: the care and welfare of immigrant Scots; and the promotion and preservation of Scottish culture in Manitoba.

We acknowledge that we live, work and gather on the traditional land of the First Nations, Treaty 1 territory and the homeland of the Métis. The St. Andrew's Society of Winnipeg recognizes the injustices of the past, and we will support and work alongside the First Nations and Métis in the spirit of reconciliation.

Committee Reports

Nominating & Governance Committee



The principal function of this Standing Committee of the St. Andrew's Society of Winnipeg is to propose a slate of suitable candidates for the Society's Officer and Board of Manager positions for consideration by the Society membership at the annual general meeting.

This committee is also mandated to conduct periodic reviews of the Society's Governance Bylaw and, if deemed advisable, may recommend By-law amendments to the Board for the Board's consideration.

The Nominating and Governance Committee meets on an as-required basis. Due to COVID-19 restrictions on the in-person gatherings which commenced in the early fall of 2020, any meetings of the committee thereafter were held virtually.

The Committee met virtually in the weeks leading up to Society's 2020 AGM and recommended a slate of Officers and Board nominees for consideration at the AGM. All nominees were elected to office for the year 2020 - 2021.

Early in 2021, the Committee endorsed and assisted in drafting a By-law amendment recommended by the Membership Committee, which created a "Family Membership" category for the Society. The By-law amendment was adopted by the Board of Managers in February 2021, and it will be presented to the 2021 AGM for permanent ratification.

Indigenous Relations



This year the committee reworked the Society's land acknowledgement to reflect our support for First Nations and Metis communities. It can be read on SASOW's website. The society donated \$1,500 for the Manitoba Keewatinowi Okimakanak North of 55 Christmas Toy Drive for 2020.

Society president Andrew Flook wrote the Prime Minister of Canada a strongly-worded letter of support for Indigenous calls to action including criminal investigations and prosecutions, and an overhaul of the child welfare system, following the discovery of hundreds of unmarked graves on former residential school grounds. A survivor's statement by Peguis First Nation Elder Dr. Raymond Mason was attached to the letter.

Board member Colin Harris and committee chair Alexandra Paul organized a gesture of reconciliation and solidarity on July 18 at the legislature between the Winnipeg Robert Burns Club and a grassroots healing camp to remember children who died at residential schools.

I took over the duties of the former Chair, Luke Settee, who championed the land acknowledgement statement and Indigenous rights on behalf of the Society.

Culture & Heritage



Despite Covid restrictions, the SASOW had perhaps its highest visibility and public participation via two very different initiatives – the "Pop-up-Piper" and the "Pop-up-Piper Snow Sculpture" contest.

There were over 20 Pop-up-Piper performances held throughout Winnipeg during the past fiscal year. Sites included Assiniboine Park, The Forks, Winnipeg City Hall, the Manitoba Legislative Building, Upper and Lower Fort Garry, Brookside Cemetery, Winnipeg Art Gallery, Jocelyn House, St. Boniface Basilica, the Scots Monument and the City of Selkirk, along with private performances at the homes of shut-in members and former SASOW presidents.

Each public performance was always accompanied by a news release and often a community newspaper, radio and television report. Although it was not always possible, many of the Pop-up-Piper performances were often accompanied by highland dancers. Throughout each performance, Covid restrictions, all performers and attendees consistently observed masking and social distancing.

In the winter of 2021-21, the Pop-up-Piper initiative created a snow sculpture contest on social media with a \$4,000 Safe at Home grant from the Government of Manitoba. In addition to the SASOW culture and heritage committee creating its snow sculptures, the committee received dozens of photos of Scottish snow sculpture entries throughout Manitoba, with cash prizes awarded for categories ranging from the best, youngest, most Scottish, largest and biggest group entry. Likes on the Group Facebook page are influential.

In addition, the SASOW Culture and Heritage Committee awarded honorary SASOW memberships to three descendants of Robbie Burns, CTV News Director Karen Mitchell; CJOB's Hal Anderson; Winnipeg Free Press columnist, Doug Speirs and community newspaper journalist Simon Fuller.

Radio and television interviews were arranged with descendants of Robbie Burns to celebrate Robbie Burns Day.

The SASOW also sponsored its annual "Kilt Skate" under the direction, support and organization of Cathy Laver-Wright. For visibility and promotion for the SASOW, this was the most successful Kilt Skate to date, with Cathy Laver-Wright skating each day of the two-month promotion (despite bitterly cold days).

For 2021-22 the Culture and Heritage Committee will continue to sponsor all three of the initiatives mentioned above and is exploring the possibilities of a speaker series and work on re-entry into a support role at the Folklorama's Scottish Pavilion.

Events & Fundraising



During the last fiscal year, COVID slashed the Society's opportunities to have in-person events.

To ensure that the Society could still raise funds despite the pandemic, we organized a raffle that featured an early bird draw in November and a final draw on December 8. The Graeat Scotch & Whisky Raffle was a huge success because board members and other members donated a bottle of their favourite scotch or whiskey, which helped the prizes cost. Two hundred tickets were printed and sold for \$50. The raffle was sold out and raised \$10,000 less minor expenses. Three prize lots plus an early bird draw included 10, 5, 3 and 1 bottles plus a set of SASOW logo Glencairn glasses, respectively.

A Ceilidh planned for April was postponed to 2022. TD Bank provided sponsorship for the postponed event.

To add some Scottish-themed winter fun in February, we applied for a Manitoba Safe at Home Grant, of which we received \$4,000 and used it to operate a Pop-Up Piper Snow Sculpture Contest. A Scottish Snowman and Snowlady was built on Tuxedo Avenue and Nanton Street to promote the contest. We also entered the SASOW snow people into the Last Snowman Winnipeg Contest. Cash prizes were given out to The McFee Family from Winnipeg for their Scottish family; Heidi Pawluk from Winnipeg for "A wee bit of Spring come early"; Jen Prior Klimack from Russell for "In honour of Robbie Burns"; The Fidler Family from Cooks Creek for Skinny Malinky longlegs; and the Ng Family from Winnipeg for the Scottish bagpiper. Honourable mention was given to the Walker Family from Oakbank for their depiction of the Manitoba Heavy Games.

The Society ran a 50/50 draw in May on the Funding Change site. The 50/50 raised an additional \$2345 for the Trust fund. Winners were Jae Eadie for ½ the pot, and Nick Logan won a Scottish Care Package.

As the year closed, it was uncertain what type of event we would be holding for the 150 celebrations. Early talks were leaning towards a hybrid event.

This year was a year of pivots. When an organization like the Society depends on special events and gathering in groups did not permit it, we had to generate safe ways to raise funds. Thank you to the Committee and the Board of Managers who enthusiastically supported the ideas, donated items, and promoted the activities of the Fundraising and Events committee.

This year's committee has a variety of members depending on the events planned.

Finance



The Finance Committee is a Standing Committee of the Board of Managers. The Society Governance By-law describes the functions of the Finance Committee: "This Committee has responsibility for ensuring the development of the annual budget by the Executive Committee. The Finance Committee will review the quarterly financial statements, including performance relative to the budget. The Committee may make recommendations to the Executive Committee and the Board regarding fiscal matters and financial policies. The Committee shall perform other such duties as may be assigned by the Board".

During the 2020-2021 fiscal year the Finance Committee carried out the quarterly and annual reviews of the financial results of the Society and the Trust Fund, relative to the budget and to the previous year, and reported upon such to the Board. The Committee ensured the development of annual budgets for the Trust Fund and the Society and reported the same to the Board. In addition, the committee considered and recommended to the Board certain other financial policies. Due to the uncertainty created by the COVID-19 pandemic, the committee met throughout the year via video conference.

Treasurer's Report - 2020-2021

This report includes the approved financial statements of the St Andrew's Society of Winnipeg Trust (the Trust) and The St Andrew's Society of Winnipeg (SASOW) for fiscal year 2020 -2021.

I have a few comments to make on the financial affairs of both organizations.

The Trust

The Trust is in a very solid position. On the revenue side, it receives a large proportion of its income from passive revenue. It received in the fiscal year over \$13,000 from interest and from proceeds from our Endowment fund with the Winnipeg Foundation. In addition, it received \$645 in donations from members. These are much appreciated.

The Trust also ran a very successful Whisky raffle which netted over \$9,000. Due to Covid, we received only two grant requests totalling \$7,000, so the net assets of the Trust net assets have risen to \$167,310. Hopefully, things will return to normal in 2021-2022, and the Trust can again fund Scottish cultural activities to the level we would like.

St. Andrew's Society of Winnipeg

The Society had an interesting financial year. Due to Covid, new ways had to be found by our events committee to cover the shortfall in our member services activities. A fifty/fifty and a Stay at home grant from the province plus merchandise sales resulted in a small positive cash flow.

On the plus side, with respect to member services, we are in a solid financial position, and revenue from membership fees rose by almost 10%.


