The Society was founded in 1871, the year after Manitoba became a province, and incorporated in 1896 by Act of the Legislative Assembly of Manitoba. At its inception, the Society had two objectives: the care and welfare of immigrant Scots; and the promotion and preservation of Scottish culture in Manitoba.

We acknowledge that we live, work and gather on the traditional land of the First Nations, Treaty 1 territory and the homeland of the Métis. The St. Andrew's Society of Winnipeg recognizes the injustices of the past, and we will support and work alongside the First Nations and Métis in the spirit of reconciliation.

Despite biting, bitterly cold weather, -46C, our challenging Manitoba members came out to defend our title as the #1 Great Canadian Kilt Skate Capital of Canada on February 28! And the big guns came out! Leading the charge were Lt. Col. Baker and The Queens Own Cameron Highlanders, kilts, bare knees, and all. Local celebrity Al Simmons kindly shared his warming hut at the Forks with our Kilt Skate participants. Then he proceeded to entertain all who joined in the skate with surprise Sottish tunes on his harmonica - you can spot a great Scot a mile away!

We did not maintain the title, but we did (as per usual) win for the coldest! Finally, celebrating his newfound recognition as a new Family membership participant was my grandson Luke. Who brought his parents along to skate. He has attended every Kilt skate since he was two weeks old!

On January 25, Robert Burns' day came along. I was privileged to be invited by the QOCH Cadets via Zoom to conduct a discussion and trivia night about our Scottish Bard; it was an unforgettable night! On Tartan Day, April 6, the Manitoba Legislature introduced and acknowledged the St. Andrew's Society we met with resounding applause. Dwight MacAulay, Pam Simmons, Peter Heavysege, and I represented the Society. Myrna Driedger, P.C.'s Speaker, invited us to her office for a photo opportunity.

We finally came together and welcomed members to the Society with the return of "The New Members Night" on May 18. Remembering the many laughs and spirits enjoyed, we cannot ignore the delicious and delicate cupcakes offered by our very own Catherine Aastrom. They disappeared rather quickly!

As the war raged in Ukraine, the Society reached out with a financial donation to the Canadian Ukrainian Congress, volunteering and fundraising to welcome Ukrainian Families at the Winnipeg Airport. The gift was towards "Comfort Bags for Children."

On May 26, I was honoured to receive an invitation to Government House to celebrate the 100th. Anniversary of the Winnipeg Police Pipe Band, and enjoy hearing the stories and the history around this very influential and talented group.

June continued with a church celebration at St. John's Cathedral, celebrating our Queen Elizabeth's Platinum Jubilee, with many SASOW members in attendance. John Perrin, a member of the Indigenous Relation Committee and I attended the 5th Anniversary of the Indigenous Accord at the Forks. SASOW was one of the first organizations to sign the Accord in 2017.

There is a quote from Matthew Kelly in <u>The Rhythm of</u> <u>Life: Living Every Day with Passion and Purpose</u>, that states:

"The people we surround ourselves with either raise or lower our standards. They either help us to become the best version of ourselves or encourage us to become lesser versions of ourselves. Membership



Membership in the Society over the past year remained stable, with renewed interest coming out of the pandemic. This is primarily due to the Events Committee's hard work as they created various events and experiences to keep SASOW members involved in the Society.

This was the first year for the new family membership category, at the rate of \$75 per family. This year we welcomed two families in this new category (Perrin and Jakilazek), and we anticipate that this category will appeal to many current and new members as we continue to build the Society.

There were 173 members in the following categories: Individual (137); Life (8); Honorary (5); Honourary Life (9); Patrons (4); Complimentary (7); Waived (1). We acknowledged the passing of the following members: Mr. William Beaton, Mr. Gordon McDiarmid, and Mr. John F. Fraser.

As part of our annual review of the Society's membership dues, the Board of Managers, based on a recommendation from the Finance Committee individual fees will increase from \$45.00 for individual members to \$60. This will take effect in January 2023. This is the first increase in close to 20 years for the St Andrews Society, and it will enable SASOW to continue to deliver the services and experiences that are valued by our members.

As we continue to elevate our role as one of Manitoba's oldest cultural societies, we are confident that we will continue to grow our membership in the coming year.

Finance



"The Finance Committee reviews the quarterly financial statements, including performance relative to the budget. The Committee may recommend fiscal matters and financial policies to the Executive Committee and the Board and performs other such duties as may be assigned by the Board".

During the 2021-2022 fiscal year, the Finance Committee carried out the quarterly and annual reviews of the financial results of the Society and the Trust Fund relative to the budget and the previous year and reported upon such to the Board. The Committee ensured the development of annual budgets for the Trust Fund and the Society and reported the same to the Board. In addition, the Committee considered and recommended other financial policies to the Board.

Due to the uncertainty created by the COVID-19 pandemic, the Committee met throughout the year via video conference.

The Committee expresses its sincere thanks to members of the Board of Managers, committee chairs, the Executive Committee and especially Treasurer David Cherrett for their assistance and timely provision of financial information. In mid-June, John Perrin resigned as chair of the Committee.

Indigenous Relations

The Indigenous Relations Committee is a Select Committee of the Board of Managers. When committee chair Alexandra Paul resigned in February, I volunteered as interim chair to complete the term balance. The Committee drafted revised Indigenous Relations Committee Terms of Reference, approved by the Board of Managers with a preamble as follows: "The Mission and Vision statements of the Society confirm our goal, as Manitobans and Canadians of Scottish ancestry, many with blood ties to Indigenous peoples is to do what we can to help foster reconciliation and build mutually respectful relationships between non-Indigenous people and First Nations, Metis and Inuit peoples."

During the year, on the Committee's recommendation, the Society sent a letter to The Hon. Mark Miller, Minister of Crown-Indigenous Relations, to support expanding eligibility for compensation of students of residential schools. The Committee also met via video conference to consider recommendations to the Board of Managers, including creating an Indigenous Calendar of Dates; assisting in identifying opportunities for Society members to develop relationships with Indigenous people; attending or supporting events organized or supported by Indigenous groups; advising the Board concerning Indigenous Relations considerations for upcoming events, and a potential project to commemorate the signing of the Peguis Selkirk Treaty in Fort Douglas Park.

Evelyn Mitchell and I represented the Society at the annual City of Winnipeg Indigenous Accord signing ceremony in June.

The Committee sincerely thanks past chairs Alex Paul, Luke Settee, Sue Bolton and the Board of Managers and Officers for their encouragement and support.

Treasurer's Report - 2021-2022

Attached are the approved financial statements of the St Andrew's Society of Winnipeg Trust (the Trust) and The St Andrew's Society of Winnipeg (SASOW) for the fiscal year 2021-2022 I have a few comments to make on the financial affairs of both organizations.

The Trust

The Trust is in a very solid position. Like last year, the Trust received a large proportion of its income from passive revenue.

In the fiscal year, it received over \$13,000 from a combination of bank interest and from an annual allocation from our Endowment fund with the Winnipeg Foundation. In addition, it received \$2335 in donations from members. These are much appreciated.

The Trust also ran a successful Whisky raffle which netted over \$5,000.

In a spectacular rebound from the Covid doldrums and with some proactive contact with other Scottish community organizations, we issued \$19,000 in grants. A listing of the donees is included in the Trust financials attached.

St. Andrew's Society of Winnipeg

The St. Andrew's Society of Winnipeg had some financial headwinds in the past fiscal year. Again ways had to be found by our events committee to try and cover the shortfall in our member services activities while being restricted in our abilities by Covid. In addition, we had to keep the St Andrew's name out there and attract new members, which meant increased promotion costs. This resulted in a substantial operating shortfall.

We were able to run a magnificent Dinner & Dance, which, as a bonus, raised money, and we ran a successful new members night and a number of Pop up Piper events, including a Remembrance Day event at Brookside Cemetery (in the snow!).

On the plus side, we are still in a solid financial position, and revenue from membership fees rose again this year.

- note 1 These funds were raised at the HADHIRIGAAN concert in June 2000 for a Scottish cultural centre. When that project did not proceed, the funds were reallocated for a heritage project to be determined.
- note 2 Funds were raised for the Settler's Monument near the site of Fort Douglas. This surplus was to be used for lighting the monument. The lighting project proved to be not economically feasible. The funds were then segregated for a project to be determined.
- note 3 The Trust requisitioned this report and an initial payment of \$5,000 was made on June 19, the report was received on July 28, 2019. There is an ongoing review of its content and payment is being withheld until this review is completed.
